


CCPA/CPRA Notice at Collection

Agiliti, Inc. collects the following personal information (PI) and sensitive personal information categories to support its business operations as listed in the business purpose section below. Personal Information does not include information excluded from CCPA's scope. Below are the categories we may collect the personal information and sensitive personal information in, and the purposes for which we intend to use this information, how long we keep the information and how we may share the information.

PERSONAL INFORMATION CATEGORIES:

- **Identifying information**, such as your full name, gender, and signature.
- **Contact information**, such as your telephone numbers and email addresses.
- **California Customer Records Personal Information Categories**, such as signature, telephone number, and other personal information which overlaps with other categories.
- **Commercial Information**, such as business name, and transaction and contact information.
- **Non-Public Education Information**, such as your Agiliti University webinar completion certificates.
- **Professional or Employment details**, such as your job title and position.
- **Internet or other similar network activity**, such as your search history, browsing history, login information, and IP addresses. - **Surveillance information**, such as call monitoring and video surveillance of the exterior of certain offices.

While we collect information that falls within the sensitive personal information categories listed in the categories above, the CCPA does not treat this information as sensitive because we do not collect or use it to infer characteristics about a person.

- To provide, support, personalize, and develop our Website, products, and services.

- To process your requests and transactions.
- To personalize your Website experience and to deliver content and product and service offerings relevant to your interests.
- To help maintain the safety, security, and integrity of our Website, products and services, databases and other technology assets, and business.
- For marketing purposes.
- To exercise or defend the legal rights of the Company and its employees, affiliates, customers, contractors, and agents.

HOW LONG TO WE KEEP YOUR INFORMATION:

We store your personal information (including sensitive personal information) for different time periods depending on the category of personal information and in accordance with applicable accounting and record retention laws. We strive to keep personal information for no longer than as needed to achieve the purpose for which it collected and to comply with applicable accounting and record retention laws. To determine how long we will retain your personal information we consider a number of factors like the category, how the personal information relates to our need to provider the services to you, and what our legal and accounting obligations are to retain the personal information.

SHARING OF INFORMATION:

We will not sell the Personal Information, including any sensitive personal information, we collect or share it with third parties for cross-context behavioral advertising.
