Introduction

Product Description

Sleep Lab Bed[™] is an air-adjustable mattress with 45 levels of soft/firm comfort settings. The mattress has a safe working load of 1,050 lb. and comes in Full XL or Queen sizes. The wired hand control provides the ability to adjust comfort settings and saves a preferred comfort level. The mattress is built with a fluid-resistant top cover, RF-welded seams, and Core Shield[™] to decrease the risk of fluid ingress and protect the mattress from contaminants for a longer useful life.




Seven Zones of Bed Rail Entrapment

If the patient would have any clinical conditions that could result in risk of falling or improperly lying in bed, the bed should be left at its lowest setting and in flat position when not attended. Agiliti recommends the use of bed rails if they are available. There are seven zones of bed rail entrapment.




Zone 1: Within the Rail




Zone 2: Under the Rail, Between the Rail Supports, or Next to a Single Rail Support






Sleep Lab Bed[™] can be placed on any conventional bed foundation, the optional Adjustable Base[™], or other properly sized adjustable bed frame. The following steps should be completed when installing the system:


- 1. Remove the standard mattress from the base (if applicable).
- 2. Replace with the Sleep Lab Bed, ensuring the air hose is at the head end of the bed.
- 3. Connect the Y adapter to both ports exiting the pump.
- 4. Place the pump under the mattress and connect the mattress hose to the Y adapter.
- 5. Connect the wired hand control to the pump.
- 6. Connect the power supply to the transformer and the transformer to the pump.
- 7. Plug the power supply into a 100 240 VAC grounded wall socket.

Air Pump

Operating Instructions



ELECTRICAL SHOCK HAZARD WARNING : Ensure the power cord is plugged into a properly grounded 100 – 240 VAC outlet.

Initial Inflation

- 1. Press the "Full" button for quick inflation. Depending on the amount of air currently inside the mattress, it may take 5 to 7 minutes to inflate fully.
- 2. Once the mattress is fully inflated, visually check to ensure the top surface is flat and firm. If the surface seems "bumpy," unzip the bottom zipper and adjust the air chamber, which may have shifted during transportation.

Adjusting your Mattress

1. Firmness

- To increase the firmness of the mattress, repeatedly press the up (+) arrow until the display reaches a desired value. The control will begin to increase the firmness until it reaches the selected firmness.
- To decrease the firmness of the mattress, repeatedly press the down
 (-) arrow until the display reaches a desired value. The control will begin to reduce the firmness until it reaches the selected firmness.

2. Autofill

To fill the mattress to maximum firmness without holding the up button, press and release the "Full" button. The mattress will increase until maximum firmness is achieved.

3. Memory

Once you have found a preferred comfort level, you can press and hold the "Mem" button for approximately 3 seconds to store your comfort setting. To return to this setting, press and release the "Mem" button, and the mattress will return to the stored comfort setting.

4. Wake Up

The center Light Bulb icon button will wake the remote from standby mode without making any adjustments.



Cleaning Instructions

CAUTION: It is recommended that gloves and protective clothing be worn during cleaning and disinfecting.



CAUTION: The product requires regular maintenance to ensure proper performance and to avoid premature wear, damage, and injury.

NOTE: Only the outer cover of the product requires cleaning and maintenance. Disassembly of the mattress for maintenance of internal components is not recommended. Do not use harsh solvents or cleaners. Special care should be taken to not puncture the support surface with needles or sharp instruments. This may result in loss of integrity of the support surface cover or internal components.

NOTE: To ensure approved chemical agents are used for top and bottom covers, visit www.agilitihealth.com/ approvedsurfacecleaners.

NOTE: DO NOT autoclave.

NOTE: Improper cleaning or rinsing, or the incorrect use of cleaning agents can lead to premature fabric discoloration, breakdown of the fabric's fluid and stain resistance, and reduced strength.

Top Cover

The top cover material is resistant to a wide variety of hospital cleaners and resists breakdown from disinfectants and cleaners containing chlorine, alcohol, peroxide, quaternary ammonium, chloramine, and phenol. Personal Protective Equipment (PPE) should always be used as directed by the disinfectant's Material Safety Data Sheet.

- 1. Prepare the disinfectant according to the manufacturer's recommendations.
- 2. Prepare a separate bucket of warm, fresh water to be used for rinsing the cover after cleaning/disinfecting procedures are completed as instructed.
- 3. All exterior areas of the top cover are to be wiped using a cloth dampened with the disinfectant, prepared as directed by the manufacturer's recommendations, to remove organic material and visible soil.
- 4. Allow the support surface shell to remain wet with a disinfectant solution for the manufacturer's recommended contact time and no longer.
- 5. Immediately after the recommended contact time, rinse all surfaces of the product with fresh water and clean cloth to remove chemical and organic residue.
- 6. Stains on the top cover may be treated using an approved stain remover, according to the manufacturer's recommendations.
 - No Abrasives: Abrasive cleaners and abrasive cleaning devices (scouring sponges) will significantly
 reduce the life of the top cover.
 - Do Not Use Solvents.
 - Follow Dilution Recommendations: One of the most significant errors made when cleaning the support surface top cover is not diluting a cleaner according to manufacturer recommendations. Most surface cleaners are sold in concentrated forms and should be diluted, usually with a large percentage of water. Failing to do this can shorten the life of the support surface top cover significantly.

Rinse after using a cleaning agent: When you wipe across a surface with a cleaner/chemical strong
enough to kill bacteria, you must rinse afterward. Leaving the cleaner to dry on the surface will shorten
the lifespan of the top cover.

NOTE: If additional cleaning is necessary, the top cover may be removed and laundered using standard hospital disinfectant/detergent. DO NOT use temperatures in excess of 170°F (76°C).

- 1. Set the washing machine to Regular Cycle.
- 2. Pre-soak with disinfectant/detergent in cold water for 10 minutes. DO NOT USE HARSH SOLVENTS OR CLEANERS.
- 3. Main wash cycle: 15 minutes (time dependent on soil level).
- 4. Rinse cycle: 5 minutes, minimum.
- 5. Spin/Drain cycle: 5 minutes, minimum

NOTE: After washing, the top cover should be air dried or placed in a dryer at very low or no heat to protect it from heat-related damage.

Bottom Cover

- 1. Prepare the disinfectant according to the manufacturer's recommendations.
- 2. Prepare a separate bucket of warm, fresh water to be used for rinsing the cover after cleaning/disinfecting procedures are completed as instructed.
- 3. All areas of the bottom cover are to be wiped using a coarse cloth dampened with the disinfectant, prepared as directed by the manufacturer's recommendations, to remove organic material and visible soil.
- 4. Allow the bottom cover to remain wet with a disinfectant solution for the manufacturer's recommended contact time and no longer.
- 5. Immediately after the recommended contact time, rinse all areas of the bottom cover with fresh water and a clean cloth to remove chemical and organic residue.
- 6. Stains on the bottom cover may be treated using an approved stain remover, according to the chemical manufacturer's recommendations.
- 7. After washing, the bottom cover must be allowed to air dry.

Pump and Hand Control

- 1. Personal Protective Equipment (PPE) should be used as directed by the Material Safety Data Sheet for the disinfectant.
- 2. Prepare the disinfectant according to the manufacturer's recommendations.
- 3. Turn off and disconnect from all electrical power to avoid electrical shock.
- 4. When cleaning the pump and hand control, avoid excessive moisture—especially in areas where there are electrical connections and components—to prevent damage.
- 5. All surfaces of the pump, hand control, and the power cord are to be wiped using a coarse cloth, dampened with the disinfectant solution prepared as directed by the manufacturer's recommendations, to remove organic material and visible soil.
- 6. Allow the pump and hand control to remain wet with disinfectant solution for the manufacturer's recommended contact time.
- 7. Rinse all surfaces of the pump and hand control with a clean cloth dampened with fresh water to remove chemical and organic residue.
- 8. After cleaning, all surfaces are to be dried with a clean, dry cloth.

NOTE: Hand clean only. DO NOT place pump in sterilization room or chamber.

Storage and Disposal

- 1. Always store products on a clean, level surface.
- 2. Avoid storing other equipment on top of the product.
- 3. Store the pump and mattress in air temperatures from 14°F to 109°F (-10°C to 43°C). DO NOT expose the pump to humidity greater than 93 percent.
- 4. End-of-life Agiliti products must be disposed of properly according to local laws and regulations. If your product contains a battery and/or electronics components, disposal of those components must be completed separately from standard waste disposal. Please contact your local authorities for disposal and recycling options.

Mattress is deflating	 Check that the hoses are not punctured, kinked, or disconnected. Inflate the mattress to the desired firmness and disconnect the pump from the mattress. a. If the mattress deflates, inspect the mattress for damage. b. If the mattress maintains firmness, contact Agiliti® for pump service.
